Nuclear Medicine Professionals in Industry

- There are many: Novartis, GSK, Merck, Lantheus, Parexel, Bristol Myers Squibb etc etc.
- Pharmaceutical companies have many departments such as Medical Affairs, Oncology Drug Development unit, Radioligand Therapy Unit.

- Imaging Project Leaders in various stages of Clinical trials
- Global head Oncology Drug Development
- Medical Liaison/Principal Scientist
- Director/Associate Director
- Scientific Lead/Medical Lead

Job market in Pharmaceuticals

- Best way to find out: Company's individual websites or various Job Search Engines such as Indeed, Linkedin etc, connection with recruiters.
- Search on the career link of the individual websites: Keyword: Nuclear Medicine, Radioligand therapy, Lead
- Director/Associate Director/Imaging Lead/Medical Science Liaison/Project leader are the most common ones.

My experience

- First job right after fellowship as Imaging Project Leader
- Clinical phase 2-3 trials
- Main job was to develop, guide and lead the imaging section of a clinical trial.
- Review PET/CT, bone scan images from the biomedical Imaging companies.
- Meetings with stakeholders such as medical societies.
- Participate in selection of the biomedical imaging company for the trial need.
- Meetings with FDA regarding new PET tracer approval process (NDA etc.)
- Organize educational meetings internally as well as externally.
